The Tomahawk Building Lofts Homeowners' Association bylaws define a quorum as "51%" of the voting power of the association, or 5 members. This quorum requirement is lowered to "25%" (2 members) at a reconvened meeting.

- 3) Insert the sealed Secret Ballot (yellow) Envelope into the provided white envelope which is addressed to the Tomahawk Building Lofts Homeowners' Association care of the HOA Election Guys
- 4) SIGN THE LEFT-HAND CORNER OF THE WHITE ENVELOPE!!!! (Your vote will not count if you do not sign the envelope)
- 5) Apply postage and mail Mailed ballots must be received by January 29, 2023.

The envelopes are already pre-addressed with our return address (and our address is also reflected on the footer of this letter).

If quorum is not reached at this meeting, the members in attendance at the meeting can vote to reconvene the meeting to a later date. In this case, the deadline for receiving ballots will be extended as well.
