The La Mirada Landmark Adult Community Association bylaws define a quorum as "a majority" of the voting power of the association, or 261 members. This quorum requirement is lowered to 25% (131 members) at a reconvened meeting. If quorum is not reached at this meeting, the members in attendance at the meeting may vote to reconvene the meeting to a later date (this is done via a voice vote of the members present at the meeting). In this case, the deadline for receiving ballots will be extended as well.

All mailed ballots should be received by us by April 18, 2023.
