The Board of Directors acknowledges the receipt of a Recall Notice for the entire Board of Directors. A Special Membership Meeting has been scheduled for December 1, 2022.

The purpose of the Special Membership Meeting will be to vote FOR or AGAINST the Recall of the Entire Board of Directors.

In the event the recall is NOT approved, each board member will retain their seats for their originally elected terms.

In the event the recall IS approved, you will then be asked to cast votes elected a new board of directors from among the list of candidates.
